## Anime Expo® 2016 Black Friday Sweepstakes Official Rules

## No Purchase Necessary. A purchase will not increase your chances of winning.

- 1. ELIGIBILITY. The Anime Expo® 2016 Black Friday Sweepstakes ("Sweepstakes") is open to residents of the 50 United States and the District of Columbia, who are 18 years of age or older at the start of the Sweepstakes ("Entrants"). Void in the U.S. Virgin Islands, U.S. Military installations in foreign countries, all other U.S. territories and possessions and wherever else restricted or prohibited by law. Sweepstakes is sponsored by Society for the Promotion of Japanese Animation, 1522 Brookhollow Drive, #1, Santa Ana, CA 92705 ("Sponsor"). - SWEEPSTAKES PERIOD. The Sweepstakes begins at 12:00:01 a.m. Pacific Time ("PT") on November 27, 2015 and ends at 11:59:59 p.m. PT on November 30, 2015 (the "Sweepstakes Period").
- **3. HOW TO ENTER.** There are two ways to enter the Sweepstakes.

Anime Expo Entries: Register to attend Anime Expo 2016 (Premiere Fan or 4-day general attendee badge) during the Promotion Period and you will be automatically entered for a chance to win. To register for Anime Expo® 2016, please visit <u>http://www.anime-expo.org/registration/</u> and complete and submit the registration form.

**Mail In Entries:** Clearly print your complete name, mailing address, city, state, zip code, email address, and day-time phone number on a 3" x 5" card or piece of paper and mail to: Anime Expo Black Friday Sweepstakes, 1522 Brookhollow, #1, Santa Ana, CA 92705. Entry must be mailed in a hand-addressed stamped envelope, postmarked by November 30, 2015 and received by December 7, 2015 to be eligible for the drawing.

Only one entry per natural person during the Sweepstakes Period regardless of method of entry.

All contact information provided must be valid, current and complete. No hand or e-mail deliveries will be accepted. All entries submitted become the sole property of Sponsor and will not be acknowledged or returned. Sponsor is not responsible for late, incomplete, void, corrupted, garbled, misdirected, or otherwise unintelligible Entries and for any problems, bugs or malfunctions Entrants may encounter when submitting their entry. Incomplete, garbled, corrupted or otherwise illegible entries are void and will not be accepted. Sponsor reserves the right to disgualify false entries or entries suspected of being false and to disqualify any Entrant it finds to be tampering with the entry process or the operation of the Sweepstakes or violating these Official Rules. Sponsor reserves the right to disqualify false entries or entries suspected of being false. Entries generated by a script, macro or other automated means will be disgualified. In the event of a dispute as to the identity of a Selected Sweepstakes Entrant, the Selected Entrant will be deemed to be, in the case of online entries, the person in whose name the e-mail account governing the e-mail address in Entrant's Anime Expo registration was opened and, in the case of mail-in entries the person whose name is written on the entry card. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible.

- 4. **ODDS.** Odds of winning a prize depend on the number of eligible entries received.
- 5. SELECTION AND NOTIFICATION OF SELECTED ENTRANT: Each qualified entry will be entered into the random drawing for one Grand Prize. A random drawing by a representative of Sponsor, from among all eligible entries received during the Sweepstakes Period, will be held on or about December 9, 2015 ("Drawing Date") to determine one (1) potential Grand Prize winner. The Selected Entrant will be notified by email. The Selected Entrant will be required to respond (as directed) within seventy eight (78) hours of attempted Notification. Selected Entrant's failure to respond timely to the Notification may result in forfeiture of the Prize, and in such case. Sponsor may randomly select an alternate Selected Entrant from among the remaining eligible entries. The Selected Entrants may be sent a declaration of eligibility / liability / publicity release ("Release"). Non-compliance with these Official Rules may result in disqualification and selection of an alternate Selected Entrant. Sponsor will not make multiple attempts to contact Selected Entrant.
