#ANIMEEXPOLITE 2020 SWEEPSTAKES OFFICIAL RULES

1. Official Rules. The #AnimeExpoLite 2020 Sweepstakes (the "Sweepstakes") is subject to these Official Rules, except as expressly stated otherwise. No purchase necessary. A purchase does not improve your chances of winning. Void where prohibited. As a condition of participating in this Sweepstakes, each Entrant waives any right to participate in a class action or have a trial by jury for any litigation directly or indirectly arising out of, under or in connection with the Sweepstakes.
