ANIME EXPO LITE 2021 THE WAY OF THE HOUSEHUSBAND GIVEAWAY OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER

- 1. Official Rules. THE WAY OF THE HOUSEHUSBAND GIVEAWAY (the "Sweepstakes") is subject to these Official Rules, except as expressly stated otherwise. No purchase necessary. A purchase does not improve your chances of winning. Void where prohibited. - **2. Eligibility**. - 5. How to Enter the Sweepstakes. During the Sweepstakes Period, you can enter the Sweepstakes by typing keyword, "Tatsu" in the Anime Expo Lite chat via https://animeexpolite.tixr.com/ or https://www.twitch.tv/animeexpo. Excessive entries of the keyword may result in disqualification.

All contact information provided must be valid, current and complete. All entries must be received by the end of the Sweepstakes period. Incomplete, garbled, corrupted, or otherwise illegible entries are void and will not be accepted. All entries submitted become the sole property of Sponsor and will not be acknowledged or returned.

In the event of a dispute as to the identity of a Sweepstakes Entrant, the Entrant will be deemed to be the person in whose name the e-mail account used by Entrant at the time of entry was opened. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible.

- 7. Liabilities. Selected Entrant is solely responsible for any and all federal, state, and local taxes on prizes. All activities related to the Prize are at Selected Entrant's own risk and subject to whatever restrictions are imposed by the entities that govern such activities. Selected Entrants may be issued an IRS Form 1099 for the ARV of any awarded Prize.
- **8. Unclaimed Prize**. a. <u>Impairment</u>. - **b.** telephone system, telephone or computer hardware, software or other technical malfunctions, lost connections, disconnections, delays or transmission errors;
- **c.** data corruption, theft, destruction, unauthorized access to or alteration of entries or other materials:
- **d.** any injuries, losses or damages of any kind caused by the Prize or resulting from acceptance, possession or use of the Prize, or from participation in the Sweepstakes; or
- **e.** any printing, typographical, administrative or technological errors in any materials associated with the Sweepstakes.

- **f.** Technical Malfunctions.
